*Haw Thakiwaki nihkanetike! (Hello, my Sac and Fox friends!) Kemenwipematethipwa (How are you)? Menohkamiwi (It's Spring) and time for many of our kikenoweni (clan feasts), menwikenwi (so it's good). Nemamatomo (I pray) wapanwi (each morning) nothenate (God, our Father) ketemakeshaki kihineneta (you think of us, take pity on) Thakiwaki (our people, Sac and Fox). Keep our people and leaders in your daily prayers!*

My dream is to have Sac and Fox tribal communities within towns in our jurisdiction as well as out of state receiving these telecasts so that more tribal members will have the opportunity to learn our Sauk language! Dreams become realities whenever we work together to accomplish these goals.

March 9, 2009 – Sac and Fox Nation Learning Center, Stroud, OK The Sac and Fox Nation in partnership with the Pawnee Nation College started the first class for college credit with “Introduction to Tribal Sovereignty” which is being offered on Monday and Wednesday evenings from 6 p.m. to 8 p.m. for eight weeks. Southwestern Oklahoma State University (SWOSU), Weatherford, Ok. in partnership with Sac and Fox Nation will start college credit classes this summer via teleconference (long distance learning). Future classes are being scheduled with Pawnee Nation College and more information for both schools may be obtained by contacting the Learning Center at (918) 968-0509.

Sauk Language classes beginning the second semester of the 2009-2010 school years. A curriculum is to be developed to teach Indian Studies consisting of tribal history and customs and tribal governments. Language could be incorporated eventually within this course. Plans are to possibly offer this course in the first semester of the 2009-2010 school years. These courses would be offered via Long Distance Learning through the new system installed at our Learning Center on the Capitol grounds in Stroud, Ok. These same goals can be reached working with other high schools within our tribal jurisdiction that have the equipment. I will be instructing our Tribal Administrator to work with the Education and Language Departments to contact the schools in Shtowateki / Stroud, Koshineki / Cushing, Chenineheki / Chandler, Pwekeki / Prague, Mikeheki / Meeker, Agra, and Ripley, in addition to Shaniheki / Shawnee to check if they have the capability for long distance learning.

I will be reporting on two topics this month: Education and Language.

### March 2009 - Long Distance Learning

arrives at Sac and Fox Nation Capitol, Stroud, OK. The long awaited equipment finally arrived and was installed during the first week of March. This equipment consists of 2 monitors and a camera that will allow our Nation to offer college credit courses through partnerships with many higher education institutions via video conference (long distance learning). We will be able to offer Sauk language classes to various locations that have the video conferencing capabilities such as high schools within our jurisdiction.

**March 7, 2009 – Tulsa City/County Central Library, Tulsa, OK** The “American Indian Festival of Words” was an event that I was able to attend that was hosted by this library. Tribal member Washington was a gracious host to Sandra Massey and myself as I was asked to briefly speak to the audience in attendance. I was very much impressed with tribal member’s art projects displayed by Jennie Bemo’s delegation of artists: Jacob Gatlin, Leah Hanson, Chevaun Gibson, Trey Bemo, Josh Gibson, Stephen Wapskineh, Angel Bemo, and Tanea Mack. Congratulations on the display of your talents, representing the Meeker Public Schools and Sac and Fox Nation.

**March 13, 2009 – Shawnee Public Schools, Shawnee, OK.** Superintendent Marilyn Bradford, Indian Education Director Graham Primeaux, and officials of Shawnee Public Schools met with a contingency of the Sac and Fox Nation; Language Director Jacob Manitowa Bailey, IT Boyd Cummings, and myself, to discuss developing an Indian Studies curriculum and offering Sauk language classes within the school system. Plans were initiated to offer

### Looking out for your kids...

According to the FBI’s National Crime Information Center, 876,213 persons reported missing to law enforcement agencies are under 18 years of age. If you were to visit the missing kids website you would find that there are currently 59 kids in Oklahoma that are classified as missing. Many of the kids that are missing are runaways, many are abducted.

For those that are abducted the reasons and persons doing the abducting are strangers, family members and even parents. The reasons for the abductions vary from custody disputes, to the terrible predatory abductions we here about on the news. Whatever the reason abductions are becoming more common. According to the the KLASS KIDS foundation

website there was a 468% jump in missing kids reports from 1982 to 2000.

The Sac & Fox Nation recently experienced our own missing kid report. On March 3, 2009 Sac & Fox Nation Police Officer, Lt. Ken Ticknor took a missing persons report from Sac & Fox tribal member Sharyl Ann Allen. She reported that her 4 year old daughter had been allowed to go on a 12 day church trip where she was due return on February 26, and never returned home.

Lt. Ticknor began his investigation on March 5th and was able to track the child through five states. On March 8th Lt. Ticknor determined the possibility that the suspect and the child were located at a residence in Albuquerque, New Mexico. Ticknor contacted and requested the assistance of the Albuquerque Po-

lice department and at the request of the SF Nation Police Dept., the child was taken into protective custody. The following morning Lt. Ticknor and our ICW (Indian Child Welfare), worker Tracy Haney traveled to New Mexico to take custody of the child. The child was returned to the mother on March 10.

Officer Ticknor has been with the SF Police Department for Seven years, and is a Criminal Investigator and is also the Probation and Parole Officer.



Following in the footsteps of his father he served in the Navy at age 17. He served in the Admiralty Islands on the destroyer USS Bache in WWII. In 1955, Jack enlisted in the U.S.A.F. where he attended air training command to be certified in aircraft mechanics. He volunteered and served two tours of duty in the Vietnam Conflict where he served as C-123 crew chief with the 19th Special Operations squadron and his tour of duty was cut short when his plane was shot down and he remained the only surviving member. In April of 1974, after 22 years of service, he retired with many honors, including a certificate of merit to the mission of Strategic Air Command for the 2d Bombardment Wing. Jack served as Trustee in the Sergeants Association and chaplain for the VFW Post 5951. His love of flying continued on after retirement where he was employed with Boeing Aircraft and Northrop Air and belonged to the Barksdale Aero Club. In 1994, he was selected by his Indian tribe, the Sac and Fox Nation, as Senior Man of the Year. He was the eldest of six siblings.

- Proof of residency in Sac and Fox Nation Jurisdiction. (Driver's License, Utility Bill or Notorized Documentaion, etc.)
- Proof of Insurance

## EARTH DAY

Earth day started in 1970 as a means to build awareness on environmental issues. Nearly 20 million Americans participated in nationwide events that focused on a goal of a healthy, sustainable environment. Today, Earth Day is an international event to provide visibility on year round efforts to improve the environment. The environmental issues facing the first Earth Day participants in 1970 are still relevant today.

To celebrate the 39th annual Earth Day, the Sac and Fox Nation's Office of Environmental Services will host an Open House on April 22, 2009 between 11:00 and 2:00 pm. The Open House will showcase the development and utilization of our latest projects to improve the environment. One of our projects is a recycling program. The program will collect numerous items to recycle on behalf of the Nation.

Last month Ginger Standing discussed sustainability. This month we will elaborate on a tool of sustainability, recycling. A good portion of what you throw in the garbage each day is paper. The U.S. EPA estimates that paper and paperboard account for almost 40 percent of our garbage. The average American household receives more than 500 pieces of advertising mail each year and the average office worker uses 10,000 sheets of copy paper each year. Advertising mail and office paper are highly recyclable.



In 2006, of plastic reached a 2.3 billion. Despite number, rate for is only 24 United States, primarily from gas. By recycling that energy available other purposes like heating and cooling our homes. For example, over 4 billion pounds of plastics were recycled in the United States in 2006, saving enough energy to heat over 2.1 million homes. Every ton of plastic bottles recycled saves about 3.8 barrels of oil. Recycled plastic bottles are used to make hundreds of everyday products, ranging from fleece jackets and carpeting to detergent bottles and lumber for outdoor decking.

Americans throw away enough aluminum every three months to rebuild our entire commercial airline fleet. The energy saved from recycling one aluminum can will operate your television set for three hours. The aluminum can is 100 percent recyclable and can be recycled indefinitely. Aluminum cans are unique in that in 60 days a can is recycled, turned into a new can and back on store shelves.

Beyond resource conservation and managing solid waste, recycling creates jobs in Oklahoma. Recent studies show that there are more than 5,000 jobs in Oklahoma created from recycling related processes. These jobs represent over 300 million dollars in payroll each year. Recycling is good for the Earth and good for the economy of Oklahoma.

### Section 205. Polling Places

(b) The Election Board shall have the authority to have Cushing be designated as an additional polling place provided, that such designation shall be published in the Tribal Newspaper and posted in the Tribal Offices thirty (30) calendar days prior to said election.

**Post by: Thursday, June 25, 2009; Published in SFN Newsletter; Posted in Tribal Offices.**

### Section 208. Poll Watchers

Each candidate may designate in writing one person, not a candidate, to watch the activities at the polls. Such designation shall be presented to Election Board Officials prior to the election. Such persons may not interfere in any way with the conduct of the election, but may observe only. Any poll watcher interfering with the election or attempting to electioneer, in any way, shall be rejected from the poll area by a Sergeant of Arms or law enforcement officer.

**Notification of Poll Watchers for the Primary Election must be in writing and received by 4:30 p.m. on Friday, July 10, 2009.**

**Notification of Poll Watchers for the General Election must be in writing and received by 4:30 p.m. on Friday, August 14, 2009.**

**All notifications must be sent to the Sac and Fox Nation Election Board, Route 2, Box 246, Stroud, OK 74079**

### Section 302. Voting List

(a) It shall be the duty of the Tribal Secretary to compile from the Tribal membership rolls a list of all persons who will be eligible voters on the date scheduled for the Primary Election and General Election and to resent sufficient certified copies of this list as requested to the Election Board no later than sixty (60) days prior to the primary Election and no later than sixty (60) days prior to the General Election. The said copies are to be returned to the Tribal Secretary.

**Deadline for Voting List: Primary Election: Tuesday, May 26, 2009**

**General Election: Tuesday, June 30, 2009**

(b) One copy of the voting list shall be maintained in the Tribal Offices and be open to public inspection during Regular business hours no later than sixty (60) days prior to the election.

**Open to the public: Primary Election: Tuesday, May 26, 2009**

**General Election: Tuesday, June 30, 2009**

### Section 303. Challenges to Voting List

(a) At any time more than twenty (20) days before the Primary Election and General Election, any person may challenge the voting eligibility of any person whose name appears on said list, or may apply to have their name added to said list by filing an application with the Election Board. The application shall clearly indicate the substance of the challenge, the specific names challenged, and the relief requested.

**Deadline for Challenges: Primary Election: Thursday, July 2, 2009**

**General Election: Friday, August 7, 2009**

### Section 401. Eligibility for Office

*This section has been declared unconstitutional in its totality pursuant to case #APL-0101 filed in Supreme Court on 7-15-05.*

### Eligibility for Office per Sac and Fox Nation Constitution:

Article VI Elections-Section 1. Any person elected to membership on the Business Committee shall not be less than twenty-one (21) years of age and shall be a member of the Sac and Fox Nation. At the time of his election he shall reside within the geographical boundaries of the State of Oklahoma. Any member of the Business Committee removing from the State of Oklahoma shall automatically forfeit his office.

### Section 402. Filing for Office

To be eligible for election and have one's name placed upon the ballot Notice of Candidacy for an elective office must be filed with: The Tribal Secretary after depositing the candidate's non-refundable filing fee of two hundred dollars (\$200.00) (cashier's check only) with the Tribal Treasurer during regular business hours at the Tribal Office complex not later than sixty-five (65) calendar days prior to the date of the Primary Election and General Elections. The Tribal Secretary shall notify the Chairman of the Election Board of all candidates who have filed for office.

**Opening Date to File for Office: Friday, January 2, 2009**

**Closing Date for Primary Election: Thursday, May 21, 2009**

**If No Primary Election is held, Closing Date for General Election: Thursday, June 25, 2009 at 4:30 p.m.**

### Section 403. Petition for Office

A petition of ten (10) or more members of Council may submit a written notice with required filing fees of two-hundred (\$200.00) non-refundable (cashiers check only), no later than sixty-five (65) calendar days prior to the date of the Primary Election and/or General Election stating the name of the candidate, age, birth date, and proof of actual residence and domicile.

**Deadline Date to Petition for Office: Primary Election – Thursday, May 21, 2009**

**If No Primary Election is held, Closing Date for General Election: Thursday, June 25, 2009**

### Section 406. Withdrawals

Any candidate for office may withdraw by filing a written notice of withdrawal with the Election Board at any time within ten (10) days after the closing date of filing for office.

Such notice shall contain the candidate's name, the office filed for, a statement of withdrawal and shall be notarized or sworn to before a person authorized to administer oaths, (Required filing fee non-refundable)

**Deadline to withdraw: Primary Election: Primary Election – May 29, 2009**

**General Election: Thursday, July 2, 2009**

### Section 408. Contest of Candidate Eligibility

Any candidate or eligible voter may challenge a candidate's legal qualification to run for office by filing a written petition with the Election Board within three (3) business days of the closing of the filing period. Each petition shall state with particularity the reasons the candidate is not eligible to file for office. There is a one-hundred dollars (\$100.00) non-refundable cashier's check contest fee.

**Deadline to contest Candidate Eligibility: Primary Election – Tuesday, May 26, 2009**

**General Election: Tuesday, June 30, 2009**

### Section 602. Application for Absentee Ballot

Qualified voters wishing to cast vote by absentee ballots shall notify the Election Board not sooner than ninety (90) days and not later than thirty (30) days prior to the election.

Such notices must be in writing and must include the correct mailing address of the person making the request. Only one ballot per written request.

**Primary Election: Opening date to request an absentee ballot: Monday, April 27, 2009**

**Deadline to request: Thursday, June 25, 2009**

**General Election: Opening date to request an absentee ballot: Monday, June 1, 2009**

**Deadline to request: Thursday, July 30, 2009**

### Section 603. Delivery of Absentee Ballot

As soon as the filing period for candidates has closed sixty-five (65) calendar days before the election, the Election Board will prepare a special ballot and send one to each qualified voter who has requested same. The Election Board shall maintain an accurate record of all absentee ballots so issued, including the name and address of the voter to whom the ballot was issued and the date of issue.

**Primary Election: Thursday, May 21, 2009**

**General Election: Thursday, June 25, 2009**

### Section 706. The Tally

The Election Board shall unlock the ballot box (es), shall remove the ballots one by one, and as each one is removed, the clerks shall read off the names of the candidates marked thereupon. At least two election officials shall view each ballot, and each counter shall keep a separate tally of the votes cast. Each Candidate may select a watcher of their choice, not a candidate, to observe and keep a separate record of the tally of the ballots, and who shall not interfere with the tally process. After the tally is complete, all ballots, absentee ballots, voter registers, and ballot boxes shall be transported to the Sac and Fox Nation Tribal Court House.

**All notifications for Tally watchers must be sent to the Sac and Fox Nation Election Board, Route 2, Box 246, Stroud, OK 74079**

**Notification of Tally Watchers for the Primary Election must be received in writing and received by 4:30 p.m. on: Friday, July 10, 2009.**

**Notification of Tally Watchers for the General Election must be received in writing and received by 4:30 p.m. on: Friday, August 14, 2009**

### Section 710. Certification of Election

The election shall be certified by the Election Board immediately after the ten (10) day period for filing an election contest expires, provided, that if an election contest petition is filed within the time period allowed, then no Certificate of Election shall be issued until after such election contest is finally decided.

**Certification of Primary Election: If the tally is completed on Saturday, July 25, 2009, Certification is on Tuesday, August 4, 2009.**

**If the tally is completed on Sunday, July 26, 2009, Certification is on Wednesday, August 5, 2009**

**Certification of General Election: If the tally is completed on Saturday, August 29, 2009, Certification is on Tuesday, September 8, 2009**

**If the tally is completed on Sunday, August -309, 2009, Certification is on Wednesday, September 9, 2009**

### Section 713. Installment in Office

Successful candidates for office whose election results are uncontested or are not involved in a run-off election shall be sworn in within ten (10) working days of the certified date, or, if there has been a delay due to election contests, run-off elections, special elections, or other cause, then as soon as reasonably practical after the election results are certified.

**Installment by: If the tally is completed on Saturday, August 29, 2009, Installment by Tuesday, September 22, 2009**

**If the tally is completed on Sunday, August 30, 2009, Installment by Tuesday, September 23, 2009**

### Section 802. Contest Petition

A candidate or qualified voter contesting a Tribal Election shall, within ten (10) days after completion of the tally of the election and declaration of the results, shall deposit a two hundred dollar (\$200.00) non-refundable cashier's check contest filing fee with the Tribal Treasurer, file with the Election Board a statement in writing setting forth their particular grounds for contest. The statement shall be verified by affidavit of the contestor (s) that they believe the matters and things therein contained are true. After the statement is filed the Election Board shall set a time for a hearing of the contest, no later than ten (10) days after the date on which the statement of contest was filed. Written notice of such hearing shall be mailed or delivered to each candidate for the office contested. Any party to the election protest and the Election Board shall have the right to view the election ballots and records in the presence of the Court Clerk in the clerk's office. Any party to the protest or a Tribal member shall be entitled to receive a photocopy of said documents certified as true and correct copies by the Court Clerk upon payment to said clerk of the normal and customary charges.

Said certified copies shall be received as evidence by the Election Board in like manner as an original. Alternatively the election Board, upon request of a party of on its own motion, may convene a hearing for any protested election at the Tribal Courthouse for the purpose of review of said election materials. After hearing the proofs and allegations of the contestants, the election Board shall make their findings and shall have authority to pronounce their judgment either setting aside, or confirming the election.

### Section 805. Request for Recount

Since the Election Ordinance provides for automatic recount of ballots, any request for recount of ballots must list the reasons therefore in writing and be submitted to the Election Board Chairman or the Chairman's designated representative within five (5) days after the election. Such request must be accompanied by a non-refundable cashier's check of two-hundred (\$200.00) made payable to the Sac and Fox Nation. Said check shall be forwarded to the Tribal Secretary-Treasurer to be credited against the cost of the recount. The Election Board shall meet and decide within ten (10) days of receipt of the notice whether or not the reasons listed in the request are sufficient to cause a recount of ballots.



## SFNEWS MAIL BAG

Dear Sac and Fox Council Members: In 2004, the Business Committee was successful in stripping Governing Council of all but a few of our rights. The 2004 Amendment was 'sold' to tribal members as giving them a right to vote on all issues rather than allowing, as they expressed, "40 members at Governing Council to Decide Issues." The effect of the passage of that amendment now allows five (5) members to make decisions on behalf of over 3300 tribal members. Using personal funds, we sent a mailing to tribal members, explaining the true effect of this amendment. However the amendment passed by some 40 votes. Since the passage of the 2004 Amendment, Governing Council as passed numerous resolutions requesting the Business Committee to hold a secretarial election (holding a vote by referendum ballot according to the terms of the Amendment). So in the past four years, how many referendum ballots have you voted on? Not a single one.

The Revenue Allocation Plan (RAP) provides that "...The Governing Council shall be the sole decision making body as to any action taken upon budget reports and requests and as to the al-

location of funds designated for Tribal Governmental operations and programs." This provision relates to the Revenue allocation funds which are derived from Casino profits (at this time). Please read an article entitled "7-1/2% Earmark on FY 09 Rap Budgets" in the February issue of the Sac and Fox News, to see how this Business Committee is overriding actions of Governing Council. A budget was approved by Governing Council, without any administrative fee. However, the Business Committee, in a subsequent emergency meeting, took action to freeze those monies approved by Governing Council until the various Committees and Boards provided budgets that included this 7.5% fee. The 7.5% deducts over \$200,000.00 from funds available for services and programs for tribal members. Governing Council would not have approved such an exorbitant amount for the Nation to write a few checks. In the alternative, a clerical position could be created to administer the budgets at a fraction of the \$200,000.00. Further, Per Capita payments are to be made on or before December 17; many tribal members received their per capita payment in Decem-

ber 2008, but some did not receive payment until February. Others have still not received their payment at this writing.

Since the passage of the 2004 Amendment, the elected officials have exerted their power over tribal members, regardless of laws, custom or tradition. It is time to do something about this. Therefore, at the request of many 'disgruntled tribal members', who include several attorneys, past elected Chiefs, former Business Committee members and other professionals, I am circulating a Petition for a Special Governing Council. The SFN Constitution provides that upon the signature of 50 tribal members, the Principal Chief SHALL (mandatory language) call a Special Governing Council. If you are ready and willing to step up and defend our rights, then I ask that you contact me for a copy of this Petition for your signature and those of your enrolled family members.

2. Candidates should never have been married, never cohabitated with a member of the opposite sex, and never had children;
3. Candidates must be alcohol-free and drug-free;
4. Candidates will be expected to have basic knowledge of traditional Sac & Fox history;
5. Selected candidates must be willing and able to attend all activities hosted by any Sac & Fox Nation Committee/Board/Commission;
6. Miss, Jr. Miss and Little Miss Sac & Fox Nation will be required to attend Red Earth, Tulsa Pow-Wow, IICOT and other events specified by the Activity Committee;
7. Miss, Jr. Miss and Little Miss Sac & Fox Nation will be hostesses for any and all visiting royalty at the Nation's Annual Pow-Wow;
8. Candidates for Miss Sac & Fox Nation must be between the ages of 17-21 years of age before June 30, 2009;
9. Candidates for Jr. Miss Sac & Fox Nation must be between the ages of 13-16 years of year before June 30, 2009; and
10. Candidates for Little Miss Sac & Fox Nation must be between the ages of 7-12 years of age before June 30, 2009.
