

**SAC AND FOX NATION  
REVENUE ALLOCATION PLAN (RAP) GUIDELINES  
FOR  
PERFECT ATTENDANCE AND/OR STRAIGHT "A" STUDENTS**

**PURPOSE OF PROGRAM:**

**Throughout Indian country it is a well-known fact that we continue to have the highest "drop-out" rates among our Indian students. We realize that children are the future of the Sac and Fox Nation; therefore, it is vital that we foster an atmosphere that encourages all children and youth to strive to obtain an education so that they may compete and succeed in a global economy. In an effort to keep the Nation's school-aged children and youth focused on education and to motivate students to remain in school we are offering an incentive to acknowledge those students who are demonstrating exemplary educational attitudes and abilities.**

**GUIDELINES:**

- Students from 1<sup>st</sup> grade through 12<sup>th</sup> grade may participate in the incentive program for "Perfect Attendance" for the entire school year.
- Students from 7<sup>th</sup> grade through 12<sup>th</sup> grade may participate in the incentive program for Straight "A" Students. Funds are limited and are on a first-come, first-served basis.
- Participants must submit a completed application form for Perfect Attendance and/or Straight "A" Students.
- Participants will need to provide the following documentation:
  - a) Tribal enrollment card (CDIB) or verification of membership in the Sac and Fox Tribe
  - b) A signed Privacy Statement
  - c) Documentation from the school supporting their request within two weeks after the school year is completed
- Each fully completed application submitted by a qualified Sac and Fox Tribal student will receive \$50.00. Funds are limited and are on a first-come, first-served basis; therefore, the Education Department will fund as many students as funding permits. **All of the documentation must be submitted along with the application in order to be considered for the incentive.**

## PRIVACY STATEMENT

The Privacy Act provides safeguards against an invasion of privacy through the misuse of records by federal agencies. Agencies which maintain a system of records on individuals are required to inform those persons on the following:

The Sac and Fox Nation may also list in the Tribal newspaper a list of student names who have received awards.
