REVENUE ALLOCATION PLAN GUIDELINES

TRIBAL ENERGY

PROGRAM FUNCTIONS:

To provide for the safe and healthy daily living needs of eligible Sac and Fox Nation tribal members with energy assistance. During the heating and cooling seasons, applicants may apply for gas, propane, wood, water and electric. This program is open to all Sac and Fox Nation tribal members, age 18 and over regardless of their location of residency.

GUIDELINES:

1. Applicant must be an enrolled member of the Sac and Fox Nation, residing anywhere. Younger tribal members that are the head of their household may also apply with documentation to support they are the head of household
2. This program can only be used if individuals are not qualified and/or have depleted LIHEAP funds. Households can either receive LIHEAP or Tribal Energy, BUT NOT BOTH for the same portion of the energy bill. There cannot be a duplication of services between LIHEAP, DOI-Emergency General Assistance, RAP-Hardship, RAP-Tribal Energy, for payment of energy bills.
3. Applicant must submit denial letter for proof that LIHEAP and DOI-Emergency General Assistance are not being duplicated or provide verification they are over the income limit to qualify for LIHEAP and other DOI services.
4. Applicant must submit energy bill they are requesting assistance with and proof of residence if the bill is not in their name or different than their address.
5. The heating season will begin October 1st and end March 30th. The cooling season will begin on April 1st and end September 30th.
6. A household may receive up to \$200.00 for heating and \$200.00 for cooling per fiscal year for energy needs regardless of the number of enrolled tribal members residing in the household. Total Energy assistance will not exceed \$400.00 per household.
7. Applicant may submit more than one request, until such time as household reaches the \$200 limit for each season, provided funds are available.
