Sarah Renee Brown was born in Shattuck, Okla. on January 11, 1985 to Spence and Janet Hummel. Sarah married Kyle Brown October 11, 2014 and the couple made their home in Sapulpa, Oklahoma. Sarah passed away unexpectedly on May 1, 2023 at the age of 38 years old.

Sarah graduated from Shattuck High School in 2003 and attended the University of Tulsa. Sarah completed her Bachelor of Arts degree in Sociology with certificates in Legal and Women's Studies in 2007. She then continued her education at University of Tulsa College of Law, completing her Juris Doctor in 2010. Sarah was admitted to the Oklahoma Bar Association in September 2010.

She was also a member of Tulsa County and the Cherokee Nation Bar Associations. At the time of her death she was a well-respected and recognized member of the Oklahoma legal community. Sarah was a life-long learner and completed a certificate in Sustainable Capitalism and ESG (Environmental, Social, Governance) from U.C. Berkeley School of Law in 2022. She was also part of the 2018 graduating class of Leadership Native Oklahoma through the American

Indian Chamber of Commerce of Oklahoma.

After graduating from law school, Sarah started her legal career with the Tulsa City Council. Her career quickly took off and she expanded her legal resume to include judgeships for the cities of Tulsa and Depew, policy analyst for the Sac and Fox Nation, professor at Oral Roberts University and The University of Arkansas, and her own private legal practice. Sarah was proud to have been a Tulsa '30 Under 30' honoree.

Sarah supported and volunteered much of her time with Tulsa Lawyers for Children. She was appointed to the Oklahoma Commission on the Status of Women in 2016. Sarah was also a professional photographer, with pieces most recently featured as a contemporary artist in the Hogue 125 Inspired Oklahoma Landscape exhibit. She also had a passion for family genealogy and her Native American heritage as a proud descendant of the Cherokee Nation and Lakota Sioux tribes.

A celebration of life was held at the Reynolds Center in Tulsa on Sunday, May 7, 2023.

Sarah is survived by her husband, Kyle; parents, Spence and Janet Hummel; brothers, Paul Hummel (Heather, nieces, Maya and Laken) and Nick Hummel (Kristin, nephews, Price and Park); Kyle's parents, David and Charlotte Brown; and twin sister, Christen Robinson; and, many close friends and colleagues.

## Seals Earns Place In Udall Program

The NASNTI REACHE Program at East Central University ha announced Delanie Seals, a senior Legal Studies major, has been accepted into the prestigious Udall Native American Congressional Internship program.

Seals is from Ada, Okla. and is a member of the Chickasaw, Choctaw, and Sac and Fox Nations. She has been involved in advocacy of various issues since she was in high school, including fighting to end discriminatory dress codes and advocating for more just police policies.

Seals currently is an intern for the Oklahoma Indian Legal Services, president of the ECU Student Government Association and a member of the ECU Native American Student Association. Seals' accolades at ECU include the 2022 Spirit of MLK Award and the 2020 Shirley Mixon Trailblazer award.

Seals has also devoted her time to a research project demonstrating the effects of the U.S. Supreme Court case McGirt v. Oklahoma on both tribal nations and the State of Oklahoma and is writing a thesis about tribal criminal jurisdictional matters for the ECU Honors Program. She plans to go to law school after getting her undergraduate degree, and work for a political and legal advocacy organization after. "Being able to participate in the Udall Internship will give me the chance to learn about the federal legislative process," Seals said, "to build connections with political and legal professionals, to learn more about tribal sovereignty, and to understand the relationship between the federal government and tribal nations."

## Partnership to Preserve Indian Boarding School Oral History, Records

The Department of the Interior and National Endowment for the Humanities (NEH) on April 26 announced a new inter-agency partnership to expand the Federal Indian Boarding School Initiative through the collection of oral histories and digitization of records documenting the experiences of survivors and descendants of federal Indian boarding school policies.

NEH has committed \$4 million to support the digitization of records from the United States' system of 408 federal Indian boarding schools and the creation of a permanent oral history collection, documenting the experiences of the generations of Indigenous students who passed through the federal boarding school system.

The Federal Indian Boarding School Initiative is an ongoing, comprehensive effort by the Interior Department to recognize the troubled legacy of federal Indian boarding school policies with the goal of addressing their intergenerational impact and shedding light on the traumas of the past.

"Federal Indian boarding school policies have touched every Indigenous person I know. Deeply ingrained in so many of us is the trauma that these policies and these places have inflicted. This is the first time in history that a U.S. Cabinet Secretary comes to the table with this shared trauma, and I'm determined to use my position to help communities heal," said Secretary Deb Haaland. "This is one step, among many, that we will take to strengthen and rebuild the bonds within Native communities that federal Indian boarding school policies set out to break." "The policies of the federal Indian boarding school system have had a profound and lasting impact on Native communities," said NEH Chair Shelly C. Lowe (Navajo). "The first step toward addressing the intergenerational consequences of these schools is to squarely acknowledge and examine the history of a federal system intended to separate families, erase Native languages and cultures, and dispossess Native peoples of their land. NEH is proud to join with the Department of the Interior in this important effort to shed light on this chapter of our country's history." Creating a permanent oral history program on the history of federal Indian boarding schools has never before been undertaken by the U.S. government and is a resource that has been requested by Indigenous communities. The Department's oral history project will ensure stories and experiences that survivors share can be understood and learned from for future generations.

In May 2022, Secretary Haaland and Assistant Secretary for Indian Affairs Bryan Newland released Volume 1 of the investigative report called for as part of the Federal Indian Boarding School Initiative. The report represented a significant step by the federal government to comprehensively address the facts and consequences of historical federal Indian boarding school policies, which resulted in the twin goals of cultural assimilation and territorial dispossession of Indigenous peoples through the forced removal and relocation of their children. Volume 2 is expected to be published by the end of 2023.

As part of the Federal Indian Boarding School Initiative and in response to recommendations from the report, Secretary Haaland launched "The Road to Healing." This year-long commitment to travel across the country is giving Indigenous survivors the opportunity to share their stories and be connected with trauma-informed support. NEH's Chair Lowe has joined Interior Department staff at several stops on "The Road to Healing," including this week's event on the Tulalip Reservation in Washington State. The oral history project will build on this effort to create space for survivors. Details regarding the facilitation of this effort will be released in the coming weeks.


In addition to NEH's direct support for the Interior Department's Federal Indian Boarding School Initiative, NEH will also fund related humanities programs, including scholarly research, convenings, and educational programs that further public understanding of the history and impact of the federal Indian boarding school system. This funding builds upon previous NEH-supported work such as the Heard Museum's Away From Home permanent exhibition of American Indian boarding school stories, and the Genoa Indian School Digital Reconciliation Project, which is digitizing and transcribing government records, photographs, oral histories, and other historical materials documenting the experience of Native American children who attended the Genoa U.S. Indian School in Nebraska between 1884 and 1934.

Hello! Sac and Fox Tribal Members

The Education Department is wrapping up the 'Every Student Success Act' (ESSA) consultations' with all the surrounding public schools. We had 29 ESSA Consultations from January through May of 2023.

Who is required to have consultation with tribes and nations? Schools that receive Indian Education Funding through Title VI Programs. Schools that receive Title VI funding of \$40,000.00 dollars and more should be contacting tribes and nations to consult with their use of federal funding. It is the tribes' and nations' responsibility to inquire as to how the federal dollars are being spent towards our Native American Students that attend that public school.

Questions should also be asked about Title I, Part A3; Part C and Part D, Title II, Part A, Title III, Part A, Title IV, Part B, Title V, Part B, Subpart 2. School Year 2021-22 data show for American Indian and Alaska Native Students in Oklahoma that attend public school the total is 156,526 students. There are 412 districts or schools eligible to receive Title VI funding in Oklahoma.

Update on the Senate Bill 429, allowing students enrolled in certain schools or institutions to wear tribal regalia during graduation ceremonies: The first reading, February 6, 2023, authored by Senator John Michael Montgomery, District 32 and Coauthored by Representative Trey Caldwell, District 63; Second reading referred to Education February 7, 2023, passed unanimously 45 Ayes and 0 Nays.

Bill was sent to the House: first reading March 23, 2023; Second reading referred to Common Education March 29, 2023, April 11, 2023 Common Education Committee passed unanimously. General order third reading April 24, 2023: House Floor passed Ayes 90, Nays 1.

Bill signed, returned to Senate, referred for enrollment April 24, 2023. Enrolled to House and signed, returned to Senate on April 25, 2023. Sent to the Governor for signature April 23, 2023. Governor vetoed May 1, 2023.

On April 22, 2023, the Education Department held the first annual Senior High School Graduate Banquet at the Grand Casino. We had 16 RSVP call-ins, and 9 graduates showed up for the event.

#### Section 408. Contest of Candidate Eligibility

Any candidate or eligible voter may challenge a candidate's legal qualifications to run for office by filing a written petition with the Election Board within three (3) business days of the closing of the filing period. Each petition shall state with particularity the reasons the candidate is not eligible to file for office. There is a one-hundred dollars (\$100.00) non-refundable cashier's check contest fee.

Each candidate may select a watcher of their choice, not a candidate, to observe and keep a separate record of the tally of the ballots, and who shall not interfere with the tally process. A candidate or qualified voter contesting a Tribal Election shall, within ten (10) days after completion of the tally of the election and declaration of the results, shall deposit a two hundred dollar (\$200.00) non-refundable cashier's check contest filing fee with the Tribal Treasurer, file with the Election Board a statement in writing setting forth their particular grounds for the contest. The statement shall be verified by affidavit of the contestor (s) that they believe the matters and things therein contained are true. After the statement is filed the Election Board shall set a time for a hearing of the contest, no later than ten (10) days after the date on which the statement of contest was filed. Written notice of such hearing shall be mailed or delivered to each candidate for the office contested. Any party to the election protest and the Election Board shall have the right to view the election ballots and records in the presence of the Court Clerk in the clerk's office. Any party to the protest or a Tribal member shall be entitled to receive a photocopy of said documents certified as true and correct copies by the Court Clerk upon payment to said clerk of the normal and customary charges.

Said certified copies shall be received as evidence by the Election Board in like manner as an original. Alternatively the Election Board, upon request of a party or on its own motion, may convene a hearing for any protested election at the Tribal Courthouse for the purpose of review of said election materials. After hearing the proofs and allegations of the contestants, the Election Board shall make their findings and shall have authority to pronounce their judgment either setting aside, or confirming the election.

# USDA Staff Members Attend Regional Nutrition Training

Channa Tiger, Distribution Manager for the Sac and Fox Nation's Stroud USDA Distribution Center and Edlyn Marquez, Program Support Specialist (Stroud USDA) were among Southwestern Region FDPIR staff members attending Community Nutrition Champion Training (CNCT) held March 28-29, 2023, in Albuquerque, New Mexico, as part of a three-year cooperative agreement between the Oklahoma Tribal Engagement Partners (OKTEP) and USDA FNS.

CNCT is a nutrition paraprofessional curriculum designed to provide nutrition education training to non-nutrition professionals who work in FDPIR and engage with participants. Attendees, who are referred to as "champions," hold many FDPIR positions, such as intake and eligibility support specialists, outreach personnel, and warehouse workers. Learning activities covered in the training included: • MyPlate nutrition; • Food labels; • Food safety; • Cooking basics; • Recipe basics; • Recipe modification; • Planning, conducting, performing, and evaluating cooking demonstrations.

I wish everything happened with perfect timing. I didn't get out in time to see you on your way. If only I knew how much it would hurt to lose a family member, how it would impact my prison stay here. I lost my soul mate Marvis Lee, my brother Randlet, and now my Uncle Terry.

It cut deep like a knife. I feel so locked up with my emotions. I just want to get out and be with my family, cry on their shoulders because I lost a lot of family. I wish it wasn't me who had to stay behind. I say to myself every day, "Get up, overcome the tasks for the day, pray, and stay productive.

When I do find my place in life, my strength, my balance, my happiness, I want you to see that I did it! I made it happen! I promise to get my kids back; to be there every milestone, every waking moment. No more absence. No more loneliness. No more growing up without a mom. Reunite with my people.

I am a strong indigenous woman. My people run through me and I carry my people in me. Aho. Usqualii-Hopi-Navajo-Sac and Fox Nation. Bye,

This program is designed to provide Lawn Care Services for the safety and healthy daily living needs of all our eligible Sac and Fox Nation Tribal Member Elders and those members who are physically disabled and cannot safely perform Lawn Care themselves, regardless of location/residency.

• Applicant(s) must be an enrolled member of the Sac and Fox Nation age 55 or older, or who is physically disabled and residing within or out of jurisdiction.

• Participants will have their lawns cut Two (2) times per month for 6 (six) months, based on available finding and number of participants served.

• Funding for this program is limited and each application will be processed in the order in which it was received. This program will fund as many Tribal Member requests as funding will permit. However, preference may be given to emergency situations.

• Applicants claiming a physical disability MUST provide a physical sician's statement.

### An-Na-Mo-Sa or Julia Mitchell of the Sauk and Fox

An-na-mo-sa, or Julia as she was commonly called, was born in Wisconsin in about 1810, and was of native heritage. In 1825, at the young age of 15, she became the wife of David D. Mitchell, a military man. Including Julia, Mitchell had about 5 wives of native blood. Mitchell became the clerk for John Jacob Astor's American Fur Company in 1828 and traveled with the company.

As tensions increased, in the summer of 1832, Illinois volunteer militia unmercifully chased Black Hawk and his people driving them to Wisconsin Heights, backing them up to the Wisconsin River. In order to buy time for the women, children, and elderly to cross the river, Black Hawk's men (about 50 Sauks and nearly 70 Kickapoos) attempted to stop the militia's advance. Black Hawk was desperately outnumbered, facing 750 militiamen, who proceeded to shoot down as many as 68 of Black Hawk's warriors. Despite the losses, their stand allowed many women and children to cross the river to safety.



Julia was one of those women. She strapped all of her possessions with her 3-year-old daughter Mary to her pony and plunged into the Wisconsin River, which was swollen to flood stage. Her pony was not able to traverse the waters as well as she supposed and halfway across the river, she took the child on her back and the pony disappeared into a whirlpool. Her friends who had made it to the other side helped her across. But when it was time to continue their escape from the pursuing army, she was so exhausted that the rest of the band had to leave her and the baby there. She and her child survived for 10 days with nothing to eat but wild onions.

Julia and Mary were captured by the Winnebagos, a tribe that was hostile to the Sauk and Fox, who took them to the Winnebago Mission where they were taken care of. Two years after her ordeal, while Julia was still living at the mission, she was walking along the same river she had crossed in escape and found something sticking out of the sand. She pushed the sand away and could hardly believe her eyes, it was a trunk that she had lost on the river crossing. As was a custom of the day, she had a chain hanging around her waist with important keys. She found the key to her trunk and opened it and all of her items were there. Most things fell to pieces as she touched them, except some silver coins and brooches.

Julia eventually married John Goodell, an Indian interpreter who was later employed at the Sac and Fox Agency here in Osage County. While Julia was married to a white man, she wanted to keep her native traditions and attended the traditional feasts and activities. John and Julia Goodell's home at the Quenemo agency was an asylum for orphans, the sick, and the needy. They adopted twins, Fannie and Isaac Baker, children of Indian trader, Isaac Baker, and his Fox wife, who had died after their birth. Fannie, who later sought to document much of the history of the Sauk and Fox in Kansas, said that her foster mother was the only true Christian she ever knew. Julia Goodell died at the Sauk and Fox agency in Oklahoma on January 8, 1880.

This year, as part of the partnership between the Chicago Blackhawks and the Sac and Fox Nation, an Advisory Committee was established to work with the Chicago Blackhawks Foundation to award grants for projects and events.

Current Membership of the Advisory Committee includes:

- Edwina Butler Wolfe
- Stella Nullake
- Angela Warrior
- Katherine Thompson

The by-laws currently allow for up to 7 members, and membership will be revisited this fall in partnership with the Business Committee.

The Advisory Committee and Blackhawks Foundation created application guidelines for Departments and Committees of the Nation to apply for funding from the Chicago Blackhawks Foundation to support projects, events and programs. The following criteria were developed:

**<u>Eligibility</u>**: For any program, project or event, the grant application should fall into one of the following categories:

- <u>Project Based Grants</u>: a one-time investment in a project for the benefit of the Sac and Fox Nation. (Example: one time investment in the purchase of health and fitness equipment available for public access)
- <u>Annual Grant Funding</u>: a continued annual investment for the benefit of the Sac & Fox Nation (Example: college scholarship funding)
- <u>Event Sponsorship</u>: a one-time investment that applies to an annual event. (Example: Powwow, Jim Thorpe Day)

Examples of what is NOT considered eligible for funding:

- Individual grants: These funds are not for individual tribal members
- Operational support: These funds are directed to specific programs, projects and events, not to
  offset annual Department operational budgets.

The Department/Committee receiving funding are asked to submit a summary on the use of funds to the Advisory Committee so that the Chicago Blackhawks Foundation can report on the full impact of grants to the Nation.

Once the Advisory Committee makes recommendations on grant awards, the awardee is asked to submit their budget to the Tribal Administrator for approval by the Budget Taskforce, and then submitted to the Business Committee.

All grants awarded this past year are outlined below. The grants awarded represent over 20% of all grant dollars the Chicago Blackhawks Foundation distributed this year to community organizations. It is the goal of the Chicago Blackhawks Foundation to continue to increase grant funding each year as the

partnership grows and more applications are submitted by Departments and Committees. The new grant process for next year will begin in August, with applications accepted through October 15th. Grants will be awarded by November.

## June is PTSD Awareness Month

Welcome to the month of June, which is PTSD Awareness Month! Is It PTSD? When you have PTSD, it's hard to feel safe. The traumatic event - natural disaster, combat, sexual assault, accident - can take hold, and you find you can't stop thinking about it. Maybe you have nightmares and trouble sleeping. Maybe you feel on edge and unsettled or don't find pleasure in things you used to enjoy. Maybe you feel it's just easier to be alone. Feelings like these are common after going through a trauma.

For most people, they pass in a few weeks or months, but for others they are long lasting. PTSD symptoms fall into four categories: reliving or re-experiencing the event, avoiding things or places that remind you of the event, negative changes in beliefs and feelings, and hyper-arousal or being on guard. For someone to be diagnosed with PTSD,

they need to have symptoms in all four categories. PTSD symptoms can happen at any age, and they come and go.

Only a mental health care provider can diagnose you with PTSD. And, knowing if you have PTSD is the first step to getting effective treatment. So, it is important to talk with a doctor if you think you have symptoms. There are effective treatments even if you have been living with symptoms for years. Keep in mind that you're not alone. And, there are treatments that will help you feel better and take back control of your life. Be the advocate, take that first step for yourself.

• 6% or 3 in every 50 American adults will have gone through PTSD or post-traumatic stress disorder at some point in their lives; • PTSD is most prevalent among American adults between the ages of 45 and 49 years old at 9.2%;

• Women have a lifetime PTSD prevalence rate of 9.7%, compared to 3.6% in men.



## Letter to Editor

## May 19, 2023 **OPINION**

In a letter from Sac and Fox Indian agent, Thomas Forsyth to Superintendent of Indian Affairs, William Clark (of Lewis and Clark fame) dated, January 5, 1827: "But even the influential chief found it expedient to bow to the wishes of the tribal council, which, in the final analysis, wielded what authority there was among the Sac and Foxes."

This tradition of our tribal government is clearly written in Article II of the Constitution which delegates "all the powers" of the Constitution to the Governing Council (GC) as "the Supreme Governing body of the Sac and Fox Nation". The Business Committee's (BC) power is limited to the enforcement of tribal laws and the administration of the daily conduct of tribal business.

But, the current members of the (BC) follow their recent predecessors, and enforce (BC) Resolutions that have been used to amend (GC) Resolutions, which changes tribal law. EXAMPLES: The 2007 Enterprise Act is a (BC) amendment of the 2003 Enterprise Act (a GC Resolution).

This takes control of the casinos and

all economic development from the oversight of (GC) shareholders. And then there's the 2008 (GC) Resolution that rescinded the (BC) Resolution for the 2007 Act (the 2003 replaces the 2007 Act!). Another unknown result is that a (GC) Resolution which removes Banning at the casinos from tribal law is not being enforced.

Instead, a (BC) amendment to the original Gaming Ordinance, which was a (GC) Resolution, allows for an Exclusion Policy at the casinos (I think exclusion means banning).

An even clearer picture of the (BC) distancing itself from tribal members is the canceling of a petitioned Special Council meeting that was to address the self-generated (BC) salary increase of \$30,000. (BC) called off this meeting before a quorum could be made. Why weren't there any attendance incentives for this meeting, like the August Council meeting?

Now is the time for one obvious solution. Elect candidates who want to change direction and go back to the 1827 ways of our elders and represent the voices of the Sac and Fox Nation and enforce its laws. John Nelson, Roll #1174 Over 70% of American Indians and Alaskan Natives live in urban areas. Yet, studies of Native elders' brain health have primarily facused on rural and reservation settings. Through brain scans and assessment of thinking and memory, the URBANE research study seeks to learn more about urban Native elders' brain health and examine how vascular brain injury, like strokes,

may contribute to increased risk of Alzheimer's Disease and Related Dementias.







My name is Robert Lincoln; I am a former U.S. Navy Corpsman. I served with the United States Marine Corps in combat operation in Iraq. I am now serving as the Health Director for the Black Hawk Health Center. It is with great honor that I do so for the people of the Sac & Fox Nation and the surrounding community.



What can I do to maintain or increase my testosterone level naturally?

- 1. Maintain healthy body weight. This is probably the most important thing a man can do. As belly fat increases, there is an increase in activity of the enzyme "aromatase," which converts testosterone in the fat cells to estrogen.
- 2. Exercise. A combination of aerobic (increase in heart rate) and resistance (weightlifting) has been found to increase the production of testosterone.
- Get a good night's sleep. Most testosterone is made during deep REM (Rapid Eye Movement) 3. sleep. A poor sleep cycle with less time spent in REM has been associated with low testosterone levels.
  - Avoid tobacco products. Tobacco reduces testosterone. 4.
- 5. Limit alcohol. Alcohol (more than two drinks a day) causes more testosterone to be converted into estrogen.

6. Manage your stress. When researchers study long term stress, they measure cortisol in the blood. This is a steroid hormone. When cortisol levels are high, they can increase fat deposits. This in turn results in more testosterone being converted into estrogen.

- 7. Eat well. Poor nutrition is at the root of many diseases. It can also create an imbalance of male hormones.
