The Sac and Fox Nation was among a group of Native American tribes hosting the Second Annual Algonquin Language and Cultural Convention held

At First Americans Museum in Oklahoma City

Sept. 30 at the First Americans Museum in Oklahoma City. Host tribes joining the Sac

and Fox Nation were the Absentee Shawnee Tribe, Cheyenne-Arapaho Tribe, Peoria Tribe, Miami Nation, Citizen Band Pottawatomie Nation and Delaware Tribe.

The convention activities included panels for the discussions pertaining to Algonquin languages, and various exhibitions including: Stomp Dance, Beading Earrings, Beaded Col-

lars, Basket Weaving, Ribbon Skirts, Moccasin Making and others.

The language panel discussion topics included: Networking; Meaningful Allies: A Story of the Miami and Peoria Tribes; Master Apprentice Program Practices; How Do We Incorporate Our Elders?; How Similar are Our Languages?; Moving Forward With Technology; and

Cultural Survival: Barriers and Best Practices.

Katie Thompson, director of the Sauk Language Program, served as moderator for the panel discussions, and Sac and Fox Nation Historian Juakin Hamilton served as master of ceremonies for outdoor activities held in the First American Museum Courtyard. Other tribal members and representatives of the Sauk Language Dept. also took part in the convention activities.

Moviegoers Learning About the ‘Osage Reign of Terror’ With Release of ‘Killers of the Flower Moon’

The opening of “Killers of the Flower Moon” has begun, and moviegoers across the world will soon know the shocking truth about the “Osage Reign of Terror.”

“It’s been something that I expected was going to happen at some point,” Osage Nation Assistant Chief R.J. Walker told the audience on Oct. 9 during Tulsa’s Native American Day Celebration. “It’s a story that was going to be told.” Walker served on a panel, along with Winnie Guess Perdue, Frances Williams, Danette Daniels and Billie Ponca, who acted in or were closely associated with the Martin Scorsese movie that opened Oct. 20.

Based on the book by David Grann, the movie stars Robert DeNiro, Leonardo DiCaprio and Native actor Lily Gladstone and tells the story of oil-rich members of the Pawhuska-based tribe murdered in the 1920s for their headrights.

Dozens of tribal citizens worked as staff members and extras as the film was being shot. Norman’s Yancey Red Corn, who portrays Chief Bonnicastle, is among the Oklahomans with speaking roles.

Walker said that during the making of the film in Osage County, he saw Scorsese and the actors “come in and respect the Osage Nation and respect the elders. They wanted to make the story right.”

Daniels, who owns the Waterbird Gallery in Pawhuska, said tribal members who were worried about how they would be portrayed and perhaps stereotyped wrote a letter to Scorsese, inviting him to a traditional Osage meal. He accepted.

About 300 people lined up against a wall, and Scorsese shook hands with each of them, which took about an hour, Daniels said. “They changed the script after that to include more about the Osage story,” with less focus on the federal investigation, Daniels said.

Perdue, who is a Cherokee elder, said the Osage and the Cherokee have a history of not getting along. But during the filming of the movie, she said, she formed close friendships. She portrayed a wealthy Osage woman who was part of a delegation to Washington.

“Never have I been met with such honor,” Perdue said of her time working on the film. “This was a spiritual experience.”

In the audience at Dream Keepers Park was Omaha tribal citizen George McCauley of Minneapolis, who had accompanied his wife to Tulsa on her business trip. McCauley is an Indian child welfare consultant and part-time actor who was an extra in the movie. He said he

played a nattily-dressed “rich Osage.”

“I didn’t know when they started filming how great a movie it was going to be,” said McCauley, whose previous film credits include “The Jingle Dress” and “A Stray.” “I was just glad they sought out real Indians. I don’t know how much time I’ll be on screen or if I’ll be recognizable, but generations from now will know who they are and what I looked like.”

Walker spoke during opening ceremonies, along with Muscogee Chief David Hill and

Cherokee Chief Chuck Hoskin Jr. The city of Tulsa rests within the boundaries of the Osage, Muscogee (Creek) and Cherokee Tribes. The seventh annual celebration was organized by the Greater Tulsa Area Indian Affairs Commission and featured singers, dancers and Indian princesses from those tribes and others across the state.

Seminole filmmaker Sterlin Harjo, co-creator of the popular “Reservation Dogs” television series, which was filmed in Oklahoma, was the scheduled (Continued on Page 10.)

Out of these unions came his children, Francis L. Grant, Jr. of Cushing, Okla., Donna Grant of Hayward, Calif., and Sara Grant, deceased.

Francis enjoyed visiting with friends and relatives and traditional native ceremonies and celebrations. He was a traditional dancer and loved to participate in dancing contests at various tribal gatherings, making many life-long friendships.

Francis was an iron worker by trade and loved the ability to construct build-

ings, whether the buildings were high risers or smaller buildings. In his later years, he developed a beautiful talent for silver work and many of his creations survive to this day.

Francis went home to his Creator on October 1, 2023, in the early morning in Cushing, Okla. He was preceded in death by his father, Austin Grant, Sr., his mother, Sarah Grant, his brother, Morgan Saginaw Grant, sister Stella Grant Wilson, and nephews J. Paul Wilson, and Jeffery Wilson and, his daughter, Sara Grant.

He is survived by his brother, Austin Grant, Jr., his son, Francis Grant, Jr. his daughter, Donna Grant and many other relatives, nephews, nieces, and grandchildren.

October 3, 2023. A graveside service was held October 4, 2023, at Hunter Cemetery in Cushing, Okla.

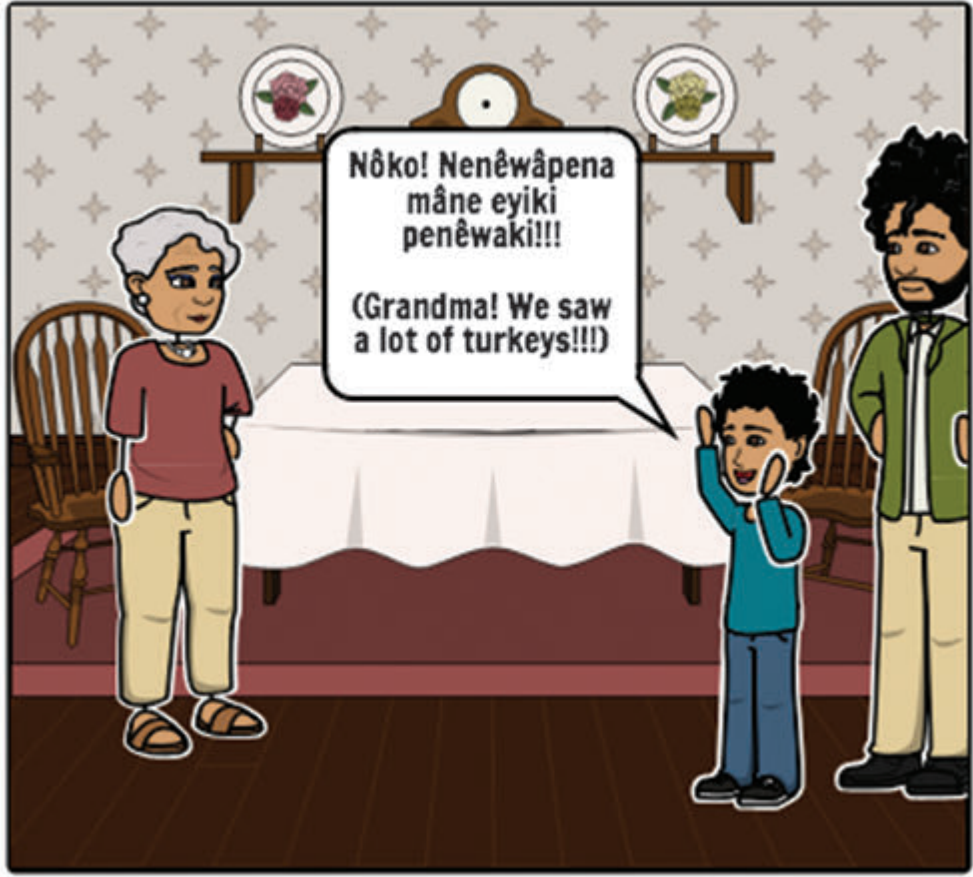
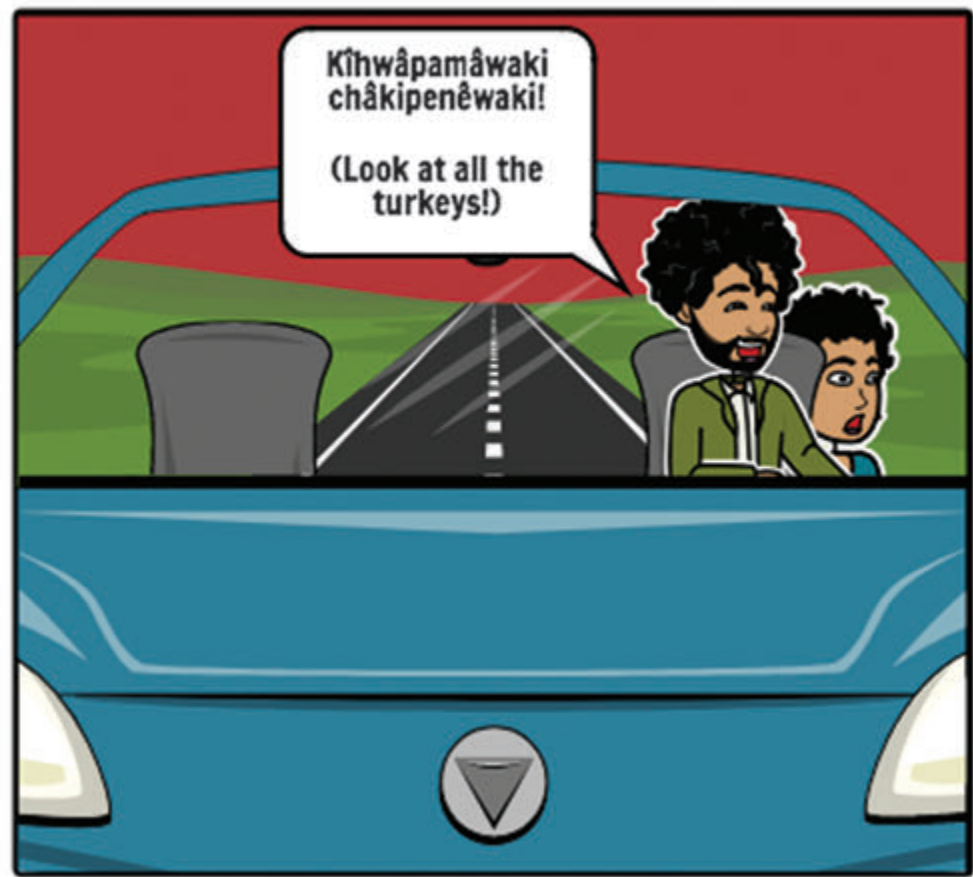

I have had the question ask many times, “What does Community Health all do”. The list of services community health provides is rather lengthy. Since this month gears toward the actions to prevent diabetes health problems, let me inform the reader of all services geared toward this action. The Community Health Department (CHD) provides nursing services that supports a coordinated and holistic approach to healthy living and chronic disease prevention. This is done by education and providing in home interventions to help the patient manage their blood glucose, blood pressure, and cholesterol levels. A Licensed Practical Nurse (LPN), Community Health Aid (CNA) and Registered Nurse (RN) conducts home visits to formula a nursing care plan with the patients of Black Hawk Health Center. The nursing intervention can include but not limited to education of medication regimen, set up of pill planners, education of healthy eating, transportation to quality food sources and navigation through all medical aspects of care. A specialty service that CHD provides is wound care monitoring and dressing changes with correspondence to Wound care provider. As we continue to build out processes, with the aim of transparency, the Chicago Blackhawks Foundation has developed a clear application and timeline. Through this process, the Advisory Committee will make **recommendations** to the Business Committee, who then will approve the grants.

Eligibility: For any program, project or event, the grant application must fall into one of the following categories:

- ☐ **Project Based Grants:** a one-time investment in a project that is a priority for the Sac and Fox Nation. (Example: one time investment in the purchase of health and fitness equipment available for public access)
- ☐ **Multi-Year Program Funding:** a continued annual investment for a long-term priority for the Sac and Fox Nation. (Example: college scholarship funding.)
- ☐ **Event Sponsorship:** a one-time investment that applies to an annual event. (Example: powwow rations)

Examples of what is NOT considered eligible for funding:

- ☐ **Individual grants:** These funds are meant to benefit the Nation as a whole, not for individual support.
- ☐ **Operational support:** These funds are directed to specific programs, projects and events, not to offset annual Department operational budgets.

Process: Application Cycle:

- October 20: Application Opens
- December 15: Application Closes
- Early January: The Blackhawks Advisory Committee (BHAC) reviews applications and make recommendations
- January/February: The Business Committee will place grant awards on meeting agenda to approve once budget task force reviews

The Department/Committee receiving funding will be asked to submit a short recap on the use of funds to the Advisory Committee for the Blackhawks annual report to the Governing Council.

Jay lived at the Sac and Fox Agency with his parents/grandparents until 1955 when the family moved to Texas. Jay graduated from Antlers Okla. High School in 1968. Jay’s life was a testament to the power of perseverance.

At the young age of 15, he rode broncs in Lewisville, Texas. He loved rodeos. He chuted horses, and he used to crease hats in a Western store in Lewisville, Texas. He worked as a long haul trucker for most of his career. Jay was also an artist. He drew many pencil and colored pencil drawings; some were used by his high school where they were displayed in and around the hallways.

Jay spent most of his life in Texas. Jay was a member of the Bear Clan. Sara Jefferson, who lived at Sac and Fox, named him along with his siblings. His name was Makwa Bunashaw.

He loved returning to Stroud for the annual Pow Wow and, to visit the old home place by the water tower. Jay was involved with the Second Baptist Church in McAlester, Okla. He was a teacher of God’s word. It was said, when he would talk about the Bible, you could hear a pin drop. They wanted to hear what he had to say. He was an excellent speaker.

Jay’s life was a journey, and like any long-haul truck driver, he knew the road was not always smooth. But he also knew that the journey was about more than the destination. It was about the people he

met along the way, the relationships he built, and the love he shared.

Jay’s life was enriched by the love and support of his family. He is survived by his three children: Dakota Jay Conallis, Tina Marie Giovanni and Christy Ann Conallis; his brother Carl Conallis and wife Rachel; and, his sisters: Judy Stephens, Tena Standish, Gloria Williams and Martha Conallis Hennig; and, three grandchildren.

Jay was preceded in death by his parents, Clifford Carl Conallis and Virginia Irene (Seymour) Conallis.

A memorial service was held Saturday, Oct. 28, 2023 at the Chaney Harkins Funeral Home Chapel with Tommy Conallis officiating.
